COBALT IN NOVEMBER 2018

The amount of cobalt contained in U.S. imports of cobalt metals and chemicals in January through November 2018 was slightly less than that imported during the same period in 2017 (table 2). The amount of cobalt contained in U.S. exports of unwrought cobalt and chemicals in January through November 2018 was 29% more than that exported during the same period in 2017 (table 4).

Prices

In November, the monthly average U.S. spot cobalt price decreased slightly from that in October 2018 and was 21% higher than that in November 2017. The monthly average LME cash mean price decreased 10% from that in October 2018 and was 15% lower than that in November 2017. The following listed prices are for cobalt metal in November, in dollars per pound.
