SILVER IN NOVEMBER 2019

U.S. mines produced 86,600 kilograms (kg) of silver in November 2019 (table 1). Based on unrounded data, the average daily silver production in November was 2,890 kg, a 20% increase compared with the revised 2,410 kg in October, and 8% more than 2,670 kg in November 2018.

Prices




Figure 1. Engelhard monthly silver prices for November 2017 through November 2019. Source: Platts Metals Week.

In November 2019, the Engelhard average daily silver price was \$17.20 per troy ounce, a slight decrease from that in October. The daily price in November ranged between a high of \$18.13 per troy ounce on November 4 and a low of \$16.81 per troy ounce on November 12 (fig. 1, table 2).

Trade

In November 2019, imports of silver in the form of bullion, doré, and ores and concentrates totaled 380,000 kg, an 11% decrease from that in October. This decrease was driven by a decrease in imports of silver bullion, which decreased in November by 16% (53,000 kg) to 288,000 kg from 342,000 kg (table 3).
