SODA ASH IN MAY 2021

In May, soda ash production was 938,000 metric tons (t), a slight increase compared with the previous month's production and 38% more than that of May 2020. Ending stocks in May decreased to 268,000 t, 3% less than those of the preceding month (tables 1, 4).

Wyoming trona production in May 2021 was 1.43 million metric tons, 24% more than the production of April 2021 and 35% more than that of May 2020 (table 1).

Exports of soda ash increased in May 2021 to 676,000 t, 46% more than those of April 2021 and 59% more than those of May 2020 (table 2,4).

May 2021 imports of soda ash were 788 t, 15% more than those of April 2021 and 18% more than that of May 2020. Soda ash import tonnages can differ significantly from month to month, but generally are much smaller than soda ash export tonnages (tables 3, 4).

Apparent consumption for May 2021 was 270,000 t, 35% less than the total for April 2021 but 32% more than the total for May 2020. Apparent consumption can change significantly from month to month mostly owing to variation in the quantity of exports but usually stabilizes over the course of the year. (table 4)
