## THE MINERAL INDUSTRY OF SIERRA LEONE

In 2017 and 2018, the production of mineral commodities—notably bauxite, diamond, gold, iron ore, titanium, and zirconium—represented at least 20% of Sierra Leone's gross domestic product (GDP), with the industrial sector representing about 10% of the GDP (Bank of Sierra Leone, 2019, p. 2). The legislative framework for the mineral sector in Sierra Leone is provided by the Mines and Minerals Act of 2009 and 2012 and the Petroleum Regulatory Act (2014). Data on mineral production are in table 1. Table 2 is a list of major mineral industry facilities. More-extensive coverage of the mineral
