- 1. "Spring Cleaning" An Edit and Verification of the North American Bird Banding Computer Files.

The systems for maintaining the North American Bird Banding Files have undergone a continual series of modifications since 1920 when the responsibility for their maintenance was transferred from the American Bird Banding Association to the Bureau of Sport Fisheries and Wildlife (then the Biological Survey). The increases in volume of data handled (about 790,000 birds banded during the 12-year period 1920 through 1931 compared to about 1,269,778 records received during calendar year 1968); the complexity of uses to which these data are put; and the increasing number of persons who wish to analyze data from our files have forced the system to evolve from the original hand-written 3"x5" card-per-bird file system through a series of increasingly sophisticated, partially automated systems to our present magnetic tape-oriented computer system.

About the only thing that has remained constant during these five decades is a continual shortage of adequate funds and personnel to:

a. Keep up-to-date in handling current incoming data and requests for data from the master files

- b. Get the "bugs" out of whatever "new" system was currently being implemented
- c. Modify the files of data fed in under "old" systems so they were completely compatible with files consisting of data fed in through "new" systems, or
- d. Maintain a satisfactory level of accuracy in incoming data or a satisfactory degree of compatibility between incoming and existing data.

This situation has allowed many small problem areas to grow to the point where portions of the files are unreliable for many research purposes.

Although we are still severely limited in both personnel and funds, we have (with the cooperation of "most of you"--see MTAB-ll and Subject 5 of this MTAB) made significant progress in both a and b above.

We now plan to tackle c and d.

All of our files are now on magnetic tape, thus making it possible to check these data more closely than ever before. This summer we plan to subject our files to a massive "edit and verification" check. This check will involve data in:

- a. The Game Bird Summary File This file contains the summarized banding data for all "game birds" banded prior to January 1, 1967.
- b. The Non-game Bird Summary File This file contains the summarized banding data for all "non-game" birds banded during the period 1955 through 1966. Data pertaining to non-game birds banded prior to 1955 have never been entered into the machine files.

These two files (a and b) will also be reformatted and combined into a single file.

- c. The Banding "Tub" File This file contains individual records for <u>all</u> birds banded since January 1, 1967 (see MTAB-10).
- d. The Recovery Statistical File This file contains one record (with both "banding" and "recovery" data) for each "recovery" report processed.

In addition to many other checks, we will:

- a. Check each code in each record against "tables of acceptable codes."
- b. Check certain codes in certain records against other codes in the same record. For example, we will check:
 - (1) The "date banded" vs. "date recovered" to insure that the bird didn't "die before it was banded." (You'd be surprised how many "do.")
 - (2) "Flyway/State" codes vs. coordinates to insure that the coordinates fall within the geographic boundaries of the "state."
 - (3) Band size vs. AOU number to help detect erroneous "AOU" numbers. (We have informed at least one duck hunter that he shot a rufous hummingbird! How closely do you double check the "AOU numbers" on your schedules?)
- c. Check records in one file against other records in that <u>same</u> file. For example, we will check <u>each</u> record in the Recovery Statistical File against every other record in that file to insure that we have only one record for each <u>dead</u> recovery. (Some birds-especially those which make the newspapers--are reported to the Banding Laboratory by as many as eight to ten <u>different</u> persons.)
- d. Check records in one file against records in other files. For example, we will check the banding data portion of each recovery record against the banding summary and tub files to insure that at least one record exists in the banding files for each record in the recovery file.

In all, we will make about 300 different checks and comparisons against the data in about 5,750,000 records representing about 23,000,000 birds. We anticipate that these checks will reveal discrepancies in hundreds of thousands of records. Each will have to be manually checked against source documents (your banding schedule or the correspondence reporting the recovery) and corrected or verified before we re-enter the data into the files.

WE PREDICT THERE WILL BE MANY THOUSANDS OF DISCREPANCIES WHICH WILL HAVE TO BE CORRECTED OR VERIFIED BY THE BANDER HIMSELF. We will request your assistance in resolving any such discrepancy detected in data pertaining to your birds.

IT WOULD PROBABLY BE A GOOD IDEA TO REVIEW YOUR FILING SYSTEM SO YOU CAN GET BACK TO YOUR FIELD NOTES IN THE EVENT SUCH ASSISTANCE IS REQUESTED.

In other words, we are going to clean out "Grandma's attic." Please have your mop and bucket ready!

2. Temporary Moratorium on Requests for Banding Data.

The "file edit and verification" described in the preceding pages will tie up most of the personnel and facilities of both the Bird Banding Laboratory and the Migratory Bird Populations Station's Automatic Data Processing Section for an extended period. During this period, many of the files will be either incomplete or inaccessible.

For these reasons, we will be unable to honor routine requests for data from our master files (see "Bird Banding Notes," Vol. 6, No. 1, p. 23) until further notice. We will attempt to honor <u>urgent</u> requests for such data when possible. If you have such a need, please accompany your data request with a detailed outline of your need for the data. If the files containing the data you need are complete and accessible, we will attempt to schedule your data extraction or arrange to have it accomplished by a commercial data processing firm. If the latter alternative is utilized, there will probably be a charge for the data extraction services.

You will be notified via "Bird Banding Notes" or another MTAE when the files are again available.

3. "Speak Now or Forever Hold Your Peace" - How Can the Recording and Submission of Banding Data Be Simplified?

Frequently, during the past few years, we have received questions from banders as to:

- a. Why do we do this or that?
- b. Why don't we do this or that?
- c. Why don't we do this that way instead of doing that this way?

Our stock reply has been:

"We have to keep doing it that way because we have been doing it that way and we can't change now."

During the next year we will have an opportunity to make some major modifications. After the data files have been edited and verified, we plan to pass them through the computer and modify some of the

existing codes. For example, we plan to adopt a revised series of "Status and Additional Information" codes which will be easier for both the bander to use in recording his data and the analyst to use in specifying which data to include and which to exclude in his analysis.

We are also considering the revision of our present "Flyway/State" codes into a more usable series of "area" codes which, among other benefits, will permit us to enter into our files the coordinates of bandings or recoveries which occur in Mexico.

WE ARE SOLICITING ANY ADDITIONAL COMMENTS OR SUGGESTIONS YOU MAY HAVE CONCERNING BANDING FORMS, CODES, PROCEDURES, OR ANYTHING ELSE WHICH APPEARS TO YOU TO BE CUMBERSOME, CONFUSING OR OBSOLETE.

Please try to phrase your comments as suggestions rather than questions. From the comments in the preceding subjects, it should be obvious that we would prefer not to increase materially our correspondence load. (For example, I still average about one letter every one and a half hours of every working day. We sometimes wonder whether we are biologists or "ornithological Ann Landers.")

Although we obviously won't be able to act favorably on everyone's suggestion or answer everyone's questions, we will take them all into consideration.

4. Will We See You? - The Regional Bird Banding Associations' Annual Meetings.

During recent years, personnel from the Banding Lab have been fortunate in being authorized to travel to the annual meeting of the various banding associations. Although we very much enjoy the opportunity to renew old acquaintances, we would also like to make some new ones among the banding fraternity.

If you have never attended a banding association meeting, why not plan on doing so this year? Here is a chance to "sharpshoot" the "bureaucrats from the Banding Lab," meet the people whose names you've seen in the banding literature and share experiences and problems with banders and birders from other areas. You don't have to be a member to attend, and I've been assured that the "welcome mat" is out to state, federal and other conservation agency personnel. 5. Who Are "the Rest of You"?

Last December in MTAB-11, we described our problems in securing data from many banders and pointed out some of the problems created by your failure to submit records or a "negative report."

As of this date--nearly two and a half months after the date your data were due--we still apparently have received neither records nor a "negative report" from about 226 banders!

This year, for the reasons described elsewhere in this MTAB, we will be unable to prepare and mail our usual series of follow-ups and reminders to coax records from reluctant banders.

Following is a list of the permit numbers and names of those persons or organizations from whom our files indicate we have not yet received either their 1968 banding records nor a "negative report." These data are listed in permit number sequence. Please check the list for your permit number and name. If they are present and:

- a. you have submitted your 1968 data, please let us know. Indicate the approximate date you mailed your schedules and some of the band numbers. We will triple check (we double checked before we prepared the list) to make sure your schedules didn't slip by our check-off system.
- b. you accomplished no bandings during 1968 and <u>did</u> submit a "negative report," please let us know the approximate date you submitted your report so we can again triple check our files.

c. you have not yet submitted your 1968 data nor a "negative report" for your permit number, please do so before May 12.

THE BANDING PERMIT OF ANY BANDER FROM WHOM WE HAVE NOT RECEIVED 1968 RECORDS, A "NEGATIVE REPORT" OR A GOOD REASON WILL FIND HIS PERMIT SUSPENDED EFFECTIVE MAY 13, 1969.
