## MAGNESIUM METAL IN THE FOURTH QUARTER 2023

Total magnesium metal imports for consumption in the fourth quarter of 2023 were 17,200 metric tons (t), 21% more than imports in the third quarter of 2023, 22% less than those in the fourth quarter of 2022, but 48% more than those in the fourth quarter of 2021 (table 1).




Figure 1. Quarterly imports of magnesium metal from the fourth quarter of 2021 through the fourth quarter of 2023. Source: U.S. Census Bureau, adjusted by USGS.

Compared with imports in the third quarter of 2023, imports of magnesium metal, scrap, and semifabricated products decreased by 36%, 28%, and 25%, respectively, but imports of alloys increased by 21% in the fourth quarter of 2023. In the fourth quarter of 2023, magnesium metal accounted for 38% of the total imports, with Israel (63%) and Turkey (27%) being the leading sources. Alloys accounted for 32% of total imports, with Czechia (45%), the Republic of Korea (22%), Hungary (9%), and Taiwan (8%) as the leading sources. Scrap accounted for 24% of the magnesium imports in the fourth quarter of 2023, with Canada (37%), Mexico (19%), and China (18%) as the leading sources (fig. 1, table 1).

Total magnesium metal exports in the fourth quarter of 2023 were 478 t, 49% less than the exports in the third quarter of 2023, 54% less than those in the fourth quarter of 2022, and 78% less than those in the fourth quarter of 2021. Exports of metal, alloys, scrap, and semifabricated product decreased by

69%, 66%, 35% and 25%, respectively, compared with exports in the third quarter of 2023 (table 1).

Canada (62%), China (13%), and Romania (8%) were the leading destinations for total magnesium exports in the fourth quarter of 2023. Canada received 60% of alloy, 17% of semifabricated product, and 96% of scrap exports. Other leading destinations for semifabricated product exports were Romania (30%), France (8%), Czechia, and the United Kingdom (6% each). China received 39% of alloy exports in the fourth quarter of 2023.

The average U.S. spot dealer import price for magnesium decreased by 11% in the fourth quarter of 2023. In Europe, the average price was 10% less at the end of the quarter compared with that of the beginning of the quarter (table 2).

#### **Update**

The decline in magnesium prices was attributed to decreased demand from consumers, high inventories, and ample supplies available from producers. Industry sources attributed increased consumer inventories to a labor dispute between the United Auto Workers union and automobile manufactures from September 15 through the end of October. Other industry sources attributed decreased consumption to some end-users switching from magnesium to other materials in response to the price spike in the fall of 2021 after US Magnesium LLC declared force majeure on contracted delivers (Jonson, 2023a, b).
