MARKETABLE PHOSPHATE ROCK MAY 2025

U.S. marketable phosphate rock production in May was 1.97 million metric tons (Mt), 17% higher than the revised amount in April and 27% higher than that in May 2024 (table 1). Total production in January through May was 8.15 Mt, 3% higher than that in the same period of 2024.

Phosphate rock sold or used in the United States in May was 1.47 Mt, 10% higher than the revised amount in April and 7% lower than that in May 2024. Total sold or used in January through May was 7.33 Mt, 8% lower than that in same period of 2024. U.S. producer stocks were 7.89 Mt, 7% higher than the revised amount in April and 17% lower than those in May 2024 (table 1).

Imports of phosphate rock in May were 309,000 metric tons, 14% higher than those in April and 6% higher than those in May 2024 (table 2). Total imports in January through May were 1.44 Mt, compared with 1.46 Mt in the same period of 2024. Imports of phosphate rock can vary substantially from month to month based on sales contracts and production schedules of the phosphate plants.

Estimated apparent consumption for 2025, based on annualized sold or used and import data, was 21.2 Mt, compared with 22.4 Mt in 2024 (table 3).
