SODA ASH IN FEBRUARY 2023

In February, soda ash production was 831,000 metric tons (t), a 6% decrease compared with the previous month's production and a 3% decrease compared with that of February 2022 (tables 1 and 4). For the first two months of 2023, soda ash production was 1.72 million metric tons (Mt), 7% less than the revised amount for the first two months 2022. Ending stocks in February were 295,000 t, 3% less than the ending stocks from the preceding month.

Wyoming trona production in February 2023 was 1.34 Mt, an 8% increase compared with the trona production in January 2023 but 4% less than the total in February 2022. For the first two months of 2023, trona production was 2.58 Mt, 14% less than the revised amount for same period of 2022 (table 1).

Exports of soda ash were essentially unchanged in February 2023 at 573,000 t, compared with those in January 2023 and 7% more than those in February 2022 (tables 2, 4). For the first two months of 2023, exports were 1.15 Mt, 13% more than the same period of 2022 (table 1). Imports of soda ash in February 2023 were 775 t compared with 603 t in January 2023. Soda ash import tonnages can differ significantly from month to month,

but generally are much smaller than soda ash export tonnages (tables 3, 4).

Apparent consumption for February 2023 was 267,000 t, 27% less than the total for January 2023 and 29% less than the estimated total for February 2022. For the first two months of 2023, apparent consumption was 635,000 t, 27% less than the revised total for the same period of 2022 (table 4). Apparent consumption can change significantly from month to month mostly owing to variation in the quantity of exports but usually stabilizes over the course of the year (table 4).

All percentages in this report were calculated using unrounded data.
