## SODA ASH IN DECEMBER 2023

In December, soda ash production was 952,000 metric tons ( t ), essentially unchanged from the previous month's production (revised), and a slight decrease compared with that in December 2022 (tables 1, 4). For 2023, soda ash production was 10.9 million metric tons (Mt), 3\% less than the production for 2022. Ending stocks in December were 251,000 $t, 21 \%$ less than those in November 2023.

Wyoming trona production in December 2023 was 1.66 Mt, 6\% more than the trona production in November 2023 (revised) and $9 \%$ more than that in December 2022. For 2023, trona production was 17.7 Mt , essentially unchanged compared with 2022 (table 1).

Exports of soda ash increased by $11 \%$ in December 2023 to $621,000 \mathrm{t}$, compared with those in November 2023 and were 8\% more than those in December 2022. For 2023, exports were 6.65 Mt , 3\% more than the amount for 2022 (tables 2, 4). Imports of soda ash in December 2023 were 421 t compared with 568 t in November 2023. Soda ash import tonnages can differ significantly from month to month, but generally are much smaller than export tonnages (tables 3, 4).

Apparent consumption in December 2023 was 400,000 t, 14\% more than that in November 2023 (revised) and 7\% more than that in December 2022. For 2023, apparent consumption was 4.38 Mt, $8 \%$ less than the total for 2022. Apparent consumption can change significantly from month to month, mostly owing to variation in the quantity of exports but usually stabilizes over the course of the year (table 4).

Table 5 provides reported U.S. soda ash consumption statistics. Reported consumption for the fourth quarter of 2023 was $1.05 \mathrm{Mt}, 10 \%$ less than the reported consumption for the fourth quarter of 2022. During the fourth quarter of 2023, there was 462,000 t (44\%) consumed for glassmaking and 316,000 t (30\%) was consumed in the production of chemicals. Reported consumption in 2023 was $4.46 \mathrm{Mt}, 4 \%$ less than reported consumption in 2022. Reported consumption for glassmaking decreased by nearly $200,000 \mathrm{t}$ in 2023, or $9 \%$, compared with that in 2022. More than half of this decrease was within the flat glass segment.

All percentages in this report were calculated using unrounded data.

Note: The annual average value of U.S. soda ash production for 2023 was $\$ 191.85$ per short ton ( $\$ 211.48$ per metric ton), an $18 \%$ increase compared with the 2022 average value of $\$ 161.95$ per short ton ( $\$ 178.52$ per metric ton). The 2023 average value sets a record high amount for the second consecutive year.
