## SODA ASH IN JANUARY 2024

In January, soda ash production was 996,000 metric tons (t), a $5 \%$ increase compared with the previous month's production and a 13\% increase compared with that of January 2023 (tables 1 and 4). Ending stocks in January were 292,000 t, 17\% more than the ending stocks from the preceding month. Wyoming trona production in January 2024 was 1.63 million metric tons (Mt), a slight decrease compared with the trona production in December 2023 but 32\% more than the total in January 2023 (table 1).

Exports of soda ash decreased 8\% in January 2024 to 573,000 t , compared with those in December 2023 but were essentially unchanged compared with those in January 2023 (tables 2, 4). Imports of soda ash in January 2024 were 746 t compared with 421 t in December 2023. Soda ash import tonnages can differ significantly from month to month, but generally are much smaller than soda ash export tonnages (tables 3, 4).

Apparent consumption in January 2024 was 382,000 t, 4\% less than the total in December 2023 but 4\% more than the total in January 2023. Apparent consumption can change significantly from month to month mostly owing to variation in the quantity of exports but usually stabilizes over the course of the year (table 4).
