SODA ASH IN MARCH 2025

Soda ash production in March was 964,000 metric tons (t) compared with 954,000 t in February, and 5% lower than that in March 2024. For the first three months of 2025, soda ash production was 2.92 million metric tons (Mt), slightly lower than that in the same period of 2024 (tables 1 and 4). Ending stocks in March were 327,000 t, 13% more than the ending stocks February (table 1).

Wyoming trona production in March 2025 was 1.63 Mt, a 12% increase over February 2025 production, and compared to 1.61 Mt in March 2024. For the first three months of 2025, trona production was 4.85 Mt compared with 4.80 Mt (revised) for the same period of 2024 (table 1).

Exports of soda ash in March were 495,000 t, 25% lower than the amount in February 2025 and 19% lower than those in March 2024. For the first three months of 2025, exports of soda ash were 1.73 Mt, 7% lower than that in the same period of 2024 (tables 2, 4). Imports of soda ash in March 2025 were 670 t compared with 599 t in February 2025. Soda ash import tonnages can differ significantly from month to month, but generally are much smaller than soda ash export tonnages (tables 3, 4).

Apparent consumption in March 2025 was 433,000 t, 35% more than the total in February 2025 but 3% less than the total in March 2024. For the first three months of 2025, apparent consumption was 1.14 Mt, 3% more than the total for the same period in 2024 (table 4). Apparent consumption can change significantly from month to month mostly owing to variation in the quantity of exports but usually stabilizes over the course of the year (table 4).

All percentages in this report were calculated using unrounded data.
