# SODA ASH IN APRIL 2025

Soda ash production in April was 955,000 metric tons (t) compared with 964,000 t in March, and slightly higher than that in April 2024. For the first four months of 2025, soda ash production was 3.88 million metric tons (Mt), compared with 3.92 Mt in the same period of 2024 (tables 1 and 4). Ending stocks in April were 203,000 t, 38% less than the ending stocks March (table 1).

Wyoming trona production in April 2025 was 1.51 Mt, a 7% decrease from that in March 2025 and also 7% less than that in April 2024. In the first four months of 2025, trona production was 6.36 Mt compared with 6.44 Mt (revised) in the same period of 2024 (table 1).

Exports of soda ash in April were 713,000 t, 44% more than the amount exported in March 2025 and 11% more than those in April 2024. For the first four months of 2025, exports of soda ash were 2.44 Mt, slightly less than that in the same period of 2024 (tables 2, 4). Imports of soda ash in April 2025 were 871 t compared with 670 t in March 2025. Soda ash import tonnages can differ significantly from month to month, but generally are much smaller than soda ash export tonnages (tables 3, 4).

Apparent consumption in April 2025 was 366,000 t, 15% less than the total in March 2025 but 26% more than the total in April 2024. For the first four months of 2025, apparent consumption was 1.51 Mt, 8% more than the revised total for the same period in 2024 (table 4). Apparent consumption can change significantly from month to month mostly owing to variation in the quantity of exports but usually stabilizes over the course of the year (table 4).

Table 5 provides reported U.S. soda ash consumption statistics. Reported consumption for the first quarter of 2025 was 1.01 Mt, 3% less than the reported consumption for the first quarter of 2024. During the first quarter of 2025, of the soda ash consumed, 444,000 t (44%) was consumed for glassmaking and 291,000 t (29%) was consumed in the production of chemicals.

All percentages in this report were calculated using unrounded data.
